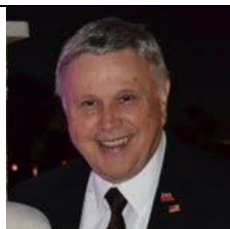

It was a different January 6 this year from when the U.S. Capitol building was stormed four years ago – as Congress formally certified Donald Trump's election as the 47th President of the United States.

In his last month in office, President Joe Biden saw fit to present a number of people with the nation's highest civilian honor – the Presidential Medal of Freedom. The list of honorees included former First Lady and Secretary of State Hillary

Rodham Clinton – and billionaire globalist George Soros. Honoring Democracy? I wonder why he didn't include Adolf Hitler, Benito Mussolini, and Benedict Arnold on the list. Days later, Biden added Pope Francis to the list, granting him the Presidential Medal of Freedom with Distinction.

The weekend before leaving office, President Biden – in the latest in his series of pardons – announced he is commuting the sentences of nearly 2,500 prison inmates throughout the United States who are serving time for nonviolent drug offenses. Earlier, Biden commuted the sentences of nearly all prisoners on federal death row, and he set a single-day record of 1,500 commutations for individuals moved to home confinement during the COVID-19 pandemic. And, of course, he also issued a sweeping pardon to his son, Hunter, for any crime that he may have committed.

Extremely cold weather in Washington, D.C. forced the inaugural ceremony activities inside the Capitol building, which greatly reduced the number of people able to watch it live. The last time it had to be indoors because of the weather was in 1985 for the beginning of **President Ronald Reagan's** second term.

Donald Trump condemned these pardons as "disgraceful," because "many of them are guilty of major crimes."

Preceding President Trump's swearing in, former **Ohio Senator J.D. Vance** took the Oath of Office as Vice President which was administered by **Supreme Court Associate Justice Brett Kavanaugh**.

Delivering a 30-minute inaugural address after being sworn in, Trump said that we have a "national emergency at the southern border," and all illegal entry will be immediately halted. Millions of illegal aliens will be deported, he added, and the "remain in Mexico" policy is being reinstated for immigrants wishing to enter the U.S. legally. Also, the "catch

and release" policy is ending. Cartels, he added, are being designated as "foreign terrorist organizations."

Trump declared that inflation will be defeated, he will declare a national energy emergency, and America once again will be a "manufacturing nation. He also spoke about establishing the External Revenue Service and the Department of Government Efficiency and called for stopping all government censorship and bringing free speech back to America.

Calling also for bringing Law and Order back to our cities, Trump said he will end the government policy of trying to socially engineer race and gender into daily life – forging a society that is "colorblind and merit based."

There were loud cheers from the audience when he said that service members who were ejected from the military for refusing the COVID vaccine will be reinstated "with full back pay." Cheers came too, when he said he would revoke the electric vehicle mandate.

Other topics covered in Trump's remarks were his plans to rename the Gulf of Mexico as "the Gulf of America," restoring the name Mount McKinley to Alaska's Mount Denali, taking back the Panama Canal, and planting the American flag on the planet Mars.

Following Trump's inaugural address, Florida's new **Republican Eighth District Congressman Mike Haridopolos** issued a statement that the speech "would have made both Teddy Roosevelt and Ronald Reagan proud." He said that Trump "outlined a bold vision of American strength and greatness that promises to lift the fortunes of every American. His speech resonated deeply with the values and priorities of hardworking families across the country." Haridopolos added that the President ".is giving voice to the American people and answering their call for a secure border, a strong military, a lower cost of living, and a return to common sense and accountability in our government."

Music in the ceremony consisted of opera singer Christopher Macchio's renditions of "Oh, America" and "The Star Spangled Banner"; Carrie Underwood singing "America the Beautiful"; and the U.S. Naval Academy Glee Club performing "The Battle Hymn of the Republic."

When the ceremony concluded, Trump then joined a large group of supporters who were unable to enter the packed room for the actual inside swearing in, and he spoke with that group even longer than he first talked.

Trump also reviewed the troops inside the Capitol building, interacting with members and bands representing all branches of the U.S. military.

Then the new President and Vice President attended the traditional luncheon in the Capitol Building, hosted by the Joint Congressional Committee on Inaugural Ceremonies.

Even though former Presidents Bill Clinton, George W. Bush and Barack Obama did attend the swearing-in ceremony, all three declined to attend the inaugural luncheon, breaking from

the long-standing tradition where past-presidents set aside differences to support the peaceful transition of power. The luncheon dates back to 1897, and skipping it shows that personal grievances and political agendas take priority over national unity,

Michelle Obama – Barack’s wife – actually was a “no show” for the entire ceremony. According to American Patriot Daily, a medical condition kept her from attending the inauguration. So what was it? The news network reported the serious condition was that her Trump Derangement Syndrome was out of control.

After lunch, Trump traveled to the Capital One Arena to view the weather-condensed traditional Inauguration Parade – which still included marching college bands, where he also spoke with family members of Israeli captives held by Hamas.

The President signed a number of executive orders at the parade and then traveled to the White House, where he answered questions from members of the media and signed dozens more executive orders.



Just a few of those orders were:

--Revoking 80 executive orders signed by former President Joe Biden

--Pardoning nearly 1,500 January 6 defendants

--Declassifying assassination files on John F. Kennedy, Robert F. Kennedy, and Martin Luther King

--Ordering federal employees back to work in-person and full-time.

--Removing the U.S. from the Paris Climate Accord

--Ending birthright citizenship.

--Declaring a national emergency on the southern border.

--Restoring the federal death penalty.

and

--Designating cartels and gangs as foreign terrorist organizations.

Hitting back at the 51 former intelligence officials who signed the bogus letter claiming that Hunter Biden’s “Laptop from Hell” was a Russian “disinformation” campaign, Trump also revoked all of their security clearances.

After changing into formal wear, the President and First Lady Melania Trump – and Vice President Vance and Second Lady Usha – attended three inaugural balls late into the evening to close out the long day. Trump also spoke at each of the events -- the Commander-in-Chief Ball, which was geared toward military service members; the Liberty Ball, attended by Trump supporters; and the Starlight Ball, involving big donors to the president.



The tradition of inaugural balls dates back to 1809, when the first one was held to honor President James Madison and his wife, Dolley.

At their first stop, the President and First Lady danced to “An American Trilogy” by Elvis Presley. "I've had no higher privilege in life than to serve as your commander in chief, not once but twice," Trump said to the cheering crowd. During his speech, he gave shout-outs to Space Force, the branch of the U.S. Armed Forces focused on military operations and defense in space, and thanked service members whom he said are some of his biggest supporters

The day before his January 20 inauguration, Trump held another signature "Make America Great Again Victory Rally" before 20,000 enthusiastic supporters at the Capital One Arena in Washington, D.C., as well as nationally televised audiences.

"We won, we won!" Trump said, as he began addressing the boisterous crowd.

The rally featured performances by several celebrities who appeared during Trump's 2024 presidential campaign, including the disco band Village People -- the '70s group behind Trump's beloved "Y.M.C.A." and his rally dance -- and country singer-songwriter Lee Greenwood, whose signature song "God Bless the U.S.A." has served as Trump's rally walk-on song.

Longtime Trump supporter and rock musician Kid Rock, country musician Billy Ray Cyrus and Liberty University's Praise Choir also performed.

POLITICAL JOTTINGS AND DOTTINGS

--The U.S. Senate met on Inauguration Day January 20 and voted unanimously 99-0 to confirm President Trump's first Cabinet nominee – **Marco Rubio** as the new U.S. Secretary of State. With Rubio's pending withdrawal as a Florida Senator, **Governor Ron DeSantis** selected **Florida Attorney General Ashley Moody** to complete Rubio's term in office. DeSantis praised Moody for her work as a staunch fighter against illegal immigration, the drug epidemic, and federal government overreach.

--The second member of Trump's national security team to be approved was **John Ratcliffe** to lead the Central Intelligence Agency, who received 74 Senate votes on January 23.

--**Secretary of Defense Pete Hegseth** became the third Trump nominee to be confirmed by the U.S. Senate late on January 24, but it took a tie-breaking 51-50 vote by **Vice**

President J.D. Vance to become official – because three RINOs joined all 47 Senate Democrats to oppose the nomination. The three so-called Republicans who voted against Trump's choice for the military assignment were Senators Mitch McConnell of Kentucky, Lisa Murkowski of Alaska and Susan Collins of Maine.

--**South Dakota Governor Kristi Noem** became the fourth Trump nominee to earn Senate confirmation on January 25, being named the new Secretary of Home Security by a 59-34 vote.

--**Ohio Governor Mike DeWine** has selected **Lieutenant Governor Jon Husted** to serve as Ohio's next U.S. Senator, replacing now-**Vice President J.D. Vance**.

--**Vivek Ramaswamy**, who was named by President Trump to co-serve with **Elon Musk** as heads of the Department of Government Efficiency (DOGE), has stepped down from that post in order to run for the soon to be vacant position of Ohio Governor.

LACEY RE-ELECTED BREC CHAIRMAN



The Brevard Republican Executive Committee met on December 30 to elect a new slate of officers, and **Chairman Rick Lacey** retained his position by defeating challenger **Blaise Trettis**, the county's Public Defender, 140 votes to 110.

Lacey said he was running "to continue the great successes that you and I, working together, have accomplished. With my leadership, the membership in BREC has tripled, fundraising has been an overwhelming success topping \$100,000 for the first time."

He noted that in the November general election in Brevard County, "Republicans have prevailed in every partisan race (as well as all but two non-partisan races) and the get-out-the-vote (GOTV) effort has been unparalleled. The numbers of registered Republicans in the county have topped 200,000 for the first time, thanks, in large part, to our focus."

The membership committees -- such as the Election Integrity and IT Committees, Registration, Social Outreach and Fundraising -- he said, "have provided BREC membership and Brevard Republicans greater voter confidence and inclusion."

Lacey added that "Working together, we defeated constitutional Amendments 3 (marijuana) and 4 (abortion) on the ballot. As I begin the 2025 legislative session, I am honored to have been appointed by **Speaker Daniel Perez** to serve on the following committees and subcommittees for the 2024-2026 term:

The State Affairs Committee, Agriculture & Natural Resources Budget Subcommittee, Education Administration Subcommittee, Industries & Professional Activities Subcommittee, and Natural Resources & Disasters Subcommittee.

In 2024, a record number of space launches took place from Cape Canaveral, with a total of 88 rockets launched compared to the old record of 72 set last year.

“We are seeing launches at a rate that would be stunning even just maybe five years ago,” said Don Platt, an associate professor with the Florida Tech College of Engineering and Science.

In the last three months, the Florida Attorney General's office has shut down six Cyber Crime Schemes. Three of these schemes targeted elderly Floridians and the other three were cases of identity theft. In a press release, the Attorney General warned that these types of crimes are becoming increasingly more common, Floridians must stay vigilant to avoid falling victim.

Attorney General Ashley Moody stated "As technology evolves, so do the tactics of scammers, but my office is constantly working to protect Floridians and hold these cybercriminals accountable."

At the last cabinet meeting of 2024, **Florida Governor Ron DeSantis** and his cabinet approved \$317 million for natural resources conservation. The Cabinet consists of **Attorney General Ashley Moody, Commissioner of Agriculture and Consumer Services Wilton Simpson, and Chief Financial Officer Jimmy Patronis.**

The Florida Forever Program was approved for \$111 million to secure 24,113 acres of critical lands, including seven key acquisitions that will connect vital conservation areas, with five located within the Florida Wildlife Corridor. Two of the acquisitions expand existing state parks, and one will create a new state park in Northwest Florida. And \$206 million was approved to preserve over 62,000 acres of Florida farms and ranches through the Florida Department of Agriculture and Consumer Services' Rural and Family Lands Protection Program.

The Department of Education continues to prioritize students, expand opportunities, and empower educators. From workforce education and teacher quality to school safety and academic progress, Florida remains steadfast in delivering a world-class education system. **Florida Commissioner of Education Manny Diaz Jr.** said, "This year's achievements reflect our commitment to Florida's students by upholding parental rights, focusing on fundamental education, and equipping students with the tools they need to succeed. Thanks to Governor Ron DeSantis, Florida continues to lead

the nation as the Education State, and we are proud to deliver on the promise of a brighter future for our students."

The Department of Education's notable achievements from 2024 include:

- Adopted new campus safety rules, requiring locked gates and classrooms, annual inspections, and unannounced compliance checks to enhance security measures.
- Florida experienced record-breaking Career and Technical Education (CTE) enrollments, including over 800,000 K-12 CTE students, 480,000 postsecondary CTE students.
- Florida was ranked first in Education by U.S. News & World Report for the second consecutive year, ranked first for Higher Education by U.S. News & World Report for the 8th consecutive year, and ranked first in Education Freedom by the Heritage Foundation for the third consecutive year.

As we begin a new year, I am excited to share updates and insights from our recent work in Tallahassee and across District 8. January marks the start of a pivotal time in our legislative calendar as

we prepare for the 2025 Legislative Session.

With our first committee week of the year behind us, I want to highlight key developments and priorities for the months ahead. One of the most impactful moments of this month was chairing the Senate Committee on Military and Veterans Affairs, Space, and Domestic Security. This committee is

central to addressing issues that resonate deeply with our district – a hub of aerospace innovation and a proud home to many veterans and military families.

The guest speaker at our January 16 meeting was **Patricia Weeks**, Deputy Mayor of the city of Cocoa, who was appointed to office last September to finish the term for District 3 councilman **Matt Barringer**. He resigned in July, citing family reasons.

Weeks spent over 40 minutes answering questions and providing information about the city. Among the topics discussed was a \$4.9 million grant given to the city to cover the cost for several double railroad crossing gates for the Brightline high-speed passenger train line. Weeks also announced that a Brightline train station is expected to open along the U.S. 1 route in 2028. Development of the Brightline station is in the planning stage as well. In addition, according to Weeks, expansion of Clearlake Road and State Road 524 are expected in the near future. Both roads are expected to be expanded to four lanes. The planning is currently underway and expected to be finished consistent with the opening of the Brightline station. Power Sports and BP are scheduled to expand on 524 west of Interstate 95.

Weeks also discussed the State mandate that residents along the Indian River in the water shed area will have to convert to advanced septic systems or to sewer by 2030. She stated that there is currently funding available to aid residents in the conversion process. Weeks, a realtor, believed that the conversion is a win for homeowners in that the connection to sewer will increase the value of the home. She noted that there is reluctance to proceed due to questions over assessments provided current funding for the conversions from sewer to septic runs out.

District 1 County Commissioner Katie Delaney answered questions that some county residents had concerning road pavement in some unincorporated areas of Brevard, stating that she is reaching out to public works concerning what roads are in line to be paved and gaging which roads residents want paved. Delaney also fielded questions concerning land field issues and waste management concerns. She urged that anyone with concerns should contact her office at: D1.Commissioner@brevardfl.gov

The January meeting also included an update of the Republican Party of Florida's attempts to block any Florida Republican Assembly members from attending Republican Executive Committee meetings across the state. At issue is the use of the name "Republican". The Florida Assembly filed a lawsuit against RPOF chair Evan Power concerning the matter. A hearing on the case was scheduled for January 27.

The assembly unveiled plans to raffle off an AR15. The drawing will take place at the February 20 meeting. Only 50 tickets will be sold. The price per ticket is \$25.00 (cash) and \$26.00 (online). Tickets can be purchased by scanning the QR code below. All online purchases will be provided with a

ticket number.

In addition, it was also revealed in the meeting that the assembly is making plans to host the state Republican



Assembly Convention in Brevard County. Plans for the event are pending.

JIMMY CARTER DIES AT AGE 100. Democrat Jimmy Carter, the 39th President of the United States and the only one to live past the century mark, died on December 29 and was interred in Plains, Georgia, next to his wife, Rosalynn, who passed away last year at the age of 96. Carter had been on hospice care at home for more than one year. A former Georgia governor and peanut

farmer, Carter had a relatively unsuccessful one-term in the White House – notable for its economic challenges and foreign policy struggles, which included seeing Iran hold more than 50 members of the U.S. Embassy staff hostage for 444 days. But an effective post-presidency time frame included creation of the Carter Center, devoted to preventing and resolving global conflicts and promoting freedom and democracy, and that led to him being honored in 2002 with the Nobel Peace Prize. Carter also worked with Habitat for Humanity to build homes for the needy. Tributes came from throughout the world and across the political spectrum. Donald Trump said that “While I strongly disagreed with him philosophically and politically, I also realized that he truly loved and respected our Country, and all it stands for. He worked hard to make America a better place, and for that I give him my highest respect. He was a truly good man and, of course, will be greatly missed.”

RESTORE THE REPUBLIC 2025. Members of several Brevard County Republican Organizations gathered in Cocoa, Florida on January 11 for a panel discussion on how to Restore the Republic in 2025. Moderator **Bill Mick** of radio station WMMB served as the group’s moderator, calling on **Bob White**, chairman of the Republican Liberty Caucus of Florida; **Tyler Sirois**, the Florida State House Majority Leader; **Brevard County Sheriff Wayne Ivey**; and gun rights advocate **Royce Bartlett** for their opinions. The panelists were in agreement on the issues, especially that the Republic cannot be restored from the top down, because Washington, D.C. is a “lost cause,” and as far as Florida is concerned, must begin locally, and then continue in Tallahassee with the State Legislature. They called for “protection of the three C’s – citizens, councils, and the Constitution.” In voting for officials, they added, it was critical to ensure that “the right people” are chosen, and not ones who campaign on issues but then once elected, change their minds. Watch how they vote, the panelists agreed, and if necessary, to look for someone else to support. Asked by Mick to name government organizations at the federal level that should be abolished, the panelists came up with the Department of Education; the Federal Reserve; and the Bureau of Alcohol, Tobacco, Firearms and Explosives. Everyone needs to “wake up,” the panelists agreed, and “fight to uphold the Constitution, no matter what.”

“NATIONAL REVIEW” MAGAZINE. This year marks the centennial for William F. Buckley Jr., the conservative

political commentator and writer, and founder and long-time editor-in-chief of “National Review.” He passed away at the age of 82, and the magazine still thrives today. This February’s issue is devoted to Buckley at 100. One article includes a delightful quote in 2005 by the writer George Will, who declared on the magazine’s 50th birthday that “Without Bill Buckley, no ‘National Review.’ Without ‘National Review,’ no Goldwater nomination. Without the Goldwater nomination, no conservative takeover of the Republican Party. Without that, no Reagan. Without Reagan, no victory in the Cold War. Therefore, Bill Buckley won the Cold War.”



Addressing the Leadership Institute’s Wednesday Wake Up Breakfast in Virginia on January 8, **Tyler O’Neil**, managing editor of the conservative website The Daily Signal, said the “real power” in Washington, D.C. lies not in the White House, but with “the Left’s dark money

and influence network that props up woke policies.” And this supports 438 different agencies that the federal government has. Using an octopus to explain the process, O’Neil said the “Woketopus” consists of big money funders, other funders, and individual campaigns, which together are demonizing conservative and Christian organizations that want to



make America a better place. The most influential of these groups, he said, is the Southern Poverty Law Center. The four pillars of this wokeism are 1), Critical Race Theory, 2) the burning of fossil fuel, 3) gender ideology, and 4) preference for technocrats and bureaucrats over American voters. O’Neil also said that unions are working against the interests of their own members by pushing for wokeness projects instead of supporting them. Also behind the movement, he said, are businesses in the U.S., which provide a long list of woke agenda items – at least 75 percent of which, O’Neil said, were adopted by the Biden Administration. Just one, he said, was asking the Border Patrol not to refer to illegal aliens as “he” or “she,” but to wait until they learn their “preferred agendas.” Referring to the “Green Revolving Door” in the United States, O’Neil said this centerpiece of Biden’s Green Movement, heavily involving John Podesta, lobbies for Democrat politics as a slush fund network. One other woke project in O’Neil’s presentation was the Anti-Israel Pressure Campaign, which like the others, involves cash flowing from donors to influencers.... The first Youth Leadership School of 2025 class consisted of 396 young leaders who had two action-packed days of training and then celebrated President



Trump’s historic inauguration. **LI President Morton Blackwell** reported that they received valuable lessons about how to organize winning activities on their campuses and run winning campaigns in their communities. They came to Washington, D.C. as students -- and they left as leaders. Now, he said, “they head back to their campuses ready to inspire their fellow students and win the fight for America’s future.” Demand for this LI training is so high, Blackwell added, that the wait list had more than 600 young people on it.... Referring to the U.S. Congress now in session, Blackwell also pointed out that Leadership Institute graduates now hold 37 seats in the House of Representatives, and 4 seats in the Senate – the most in LI history. The new members, he said, are **Indiana Senator Jim Banks, Alaska Congressman Nicholas Begich III, Colorado Congressman Gabe Evans, and Virginia Congressman John McGuire.**



Bob White, the chairman of the Republican Liberty Caucus of Florida for the past decade, as well as the RLC Brevard for 16 years, told the Heritage

Isle Republican Club meeting on January 2 that he is a candidate for the special election to fill the District 32 seat in the Florida State Legislature because he “sees himself as a reformer looking for changes.” He is one of four Republicans running for the seat – which was won in the November election by Debbie Mayfield, but she is giving it up in order to return to the State Senate instead. White said he is waiting for the Supervisor of Elections to announce when the special election will be held. White, who has numerous endorsers for the House seat, pointed out that the Republican Liberty Caucus grades all state legislators every term on how they vote on 20 specific pieces of legislation. Even though in the 2023 session Republicans had super majorities in the Senate – 27 of 40 members -- and the House – 86 of 120 members – he said, only three legislators earned A’s for their support of key issues. The legislative leaders work with “the donor class and lobbyists,” White said, and do not always support issues that the RLC favors. Explaining that legislators are limited in the amount of campaign money they can receive from individuals, when it comes to political committees, “there are no limits.” In his campaign, White defines himself as having “a platform of faith, family, freedom and Florida.” His key issues, he said, are “to defend the border, combat inflation, stop over-development, and fix the insurance rates.” And, he said, his campaign is “a call to action for all who believe in liberty, accountability, and a government that serves its people – not the other way around.” White, a fourth-generation Floridian



and a proven champion of liberty and freedom, is devoted to his wife, Flo, his three children, and five grandchildren. His website is www.bobwhiteforflorida.com.

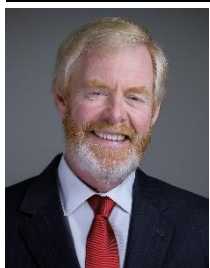

“A Texas school district felt the wrath of every church-going citizen in the Panhandle after they compared the Holy Bible to pornography and banned God’s Word from school libraries. Canyon Independent School District Superintendent. Darryl Flusche told parents in an email that he had ordered librarians to remove the Good Book in compliance with a new state law called the ‘Restricting Explicit and Adult-Designated Educational Resources’ Act. The law is aimed at removing sexually explicit material from school libraries – especially materials

that ‘describe or portray sexual conduct...in a patently offensive way. The superintendent wrote in a letter to parents: This standard for library content prohibits books that have one instance of sexual content as described above, therefore, HB 900 doesn’t allow numerous books, including the full text of the Bible, to be available in the school library.’ Parents and preachers showed up at a recent school board meeting to voice their extreme displeasure. ‘In a day when we are needing security guards and bulletproof windows and doors, I think having the Word of God available to our children cannot only be preventative to violence but also provide comfort and a sense of security in a chaotic world,’ parent Regina Kiehne told the school board. ‘It seems absurd to me that the Good Book was thrown out with the bad books.’ State Representative Jared Patterson, a Republican co-author of the bill, blasted the superintendent’s decision to yank the Bible from the bookshelves. ‘The superintendent’s position here was indefensible and appeared to be a result of open hostility toward folks who want sexually explicit content removed from public schools. HB 900 clearly protects the Bible and all religious texts,’ he wrote on X. Patterson then fired off a letter to the school superintendent warning that his actions may have violated the law.’ The Bible is the most important and most read book in history, and removing it does a grave injustice to the students in your care,’ the lawmaker wrote. ‘Let me be very clear: the Bible and other religious texts are protected under HB 900. Any assertion to the contrary is either rooted in ignorance of state law or an open hostility to the will of the people.’ That letter left the superintendent and school board members sweating like sinners in church. And after that ‘Come to Jesus” board meeting – they reinstated the Bible.... Needless to say, banning the Bible in Texas was one of the biggest boneheaded decisions made in the Lone Star State. It ranks right up there with letting men become Dallas Cowboy cheerleaders or saying brisket really isn’t barbecue.”



“The Federalist” national correspondent **Tristan Justice**, writing on the top ten lies of Liz Cheney and the January 6 Committee four years after the Capitol demonstrations:

Because House rules dictate that ranking committee members must be appointed by the minority party, Cheney, who was appointed by the Democrat speaker at the time, served as the panel's vice chair.... Pelosi's commission targeted private citizens who exercised their constitutional right of free assembly. The legitimacy of the committee's actions has always remained in question, since Congress is not one of the branches of government tasked with investigating alleged crimes of private citizens."



Journalist **Ben Zeisloft**, writing on a teacher suing her school over refusal to use trans pronouns, in "The Western Journal":

"A Christian middle school teacher from Ohio will receive a sizable payout from her government school employer after administrators tried compelling her to call two self-described transgender students by their preferred names and pronouns. Jackson Local School District settled with the teacher, Vivian Geraghty, for \$450,000 in damages and attorney fees following a lawsuit in which she argued that her First Amendment rights were violated, according to the Alliance Defending Freedom, which represented her. She had been forced to resign from her position as English teacher for refusing to comply with a demand to enable the 'social transition' of two students who did not want to be called by their names and pronouns as listed on the school roster. Geraghty could not fulfill that request because it violated her Christian convictions....'If that is your final decision, then we need a letter of resignation effective today,' the teacher said she was told..... Logan Spena, legal counsel for the Alliance Defending Freedom, said in a statement, 'The First Amendment prohibits that abuse of power, and Jackson Local School District officials have learned that comes at a steep cost.' The legal nonprofit added that Geraghty's religious beliefs and understanding of science 'govern her view that a person is male, or female based on sex, not personal identity, and participating in a student's social transition violates those beliefs by forcing her to communicate messages she believes are untrue and harmful to the student. She has received just vindication for taking this stand'.... Attorneys for the Alliance Defending Freedom also won a \$575,000 settlement for Peter Vlaming, a teacher in Virginia who faced a similar crackdown. They likewise won religious accommodation for teachers Deborah Figliola, Kristine Marsh, and Laura Nelson in their battle with Harrisonburg, Virginia, City Public Schools for a similar case. The legal victory of Geraghty, not to mention these other teachers, shows that doing what is right always pays off in the end, maybe in a very literal sense. These students, who are often confused and on a search for their own identity, wanted to convince others to lie about them amid that search, and most adults went along with the charade. But their Christian

teachers loved them and feared God too much to lie about them in this way."



American Security Council Foundation Senior Analyst Laurence F. Sanford, writing on "Tariffs are Taxes" for his "Sanford On Security" publication:

"A tariff is a tax placed by a government on goods that cross national borders. Countries do not pay tariffs; the importing purchaser pays tariff taxes to the government or the collecting government agencies. If a Chinese company sells a widget for \$100 without tariffs, the importing purchaser pays \$100. If the U.S. Government imposes a 50% tariff on the widget, the importing purchaser then pays \$150. China receives \$100, and the U.S. government receives \$50. Tariff taxes distort market efficiencies by causing the price of a product to be higher than it otherwise would be in a free market. However, there is no free market pricing with international trade. The price is determined by many factors, including the amount of government subsidies, restrictions, regulations, and political agenda. Tariffs can cause inflation, since prices usually rise, but not always. President Reagan negotiated import quotas (a tariff) on Japanese cars, forcing Japanese companies to invest billions of dollars in the non-union U.S. South to build cars. A few years later, the quotas were lifted, and prices returned to normal. Tariffs protect domestic industries from foreign competition that may have open or hidden government aid. China's state-owned enterprises receive government financing and other favorable treatment that U.S. companies do not receive. SOEs are frequently used to implement the Chinese Communist Party's centralized control policy of socioeconomic stability (police state), the building of infrastructure, and world economic and military domination. President Trump campaigned to impose blanket tariffs of 10% to 20% on all imports, with additional tariffs of 60% to 100% on goods from China. The U.S. trade deficit in 2023 totaled \$773 billion.... Trump also threatened additional tariffs on Mexico and Canada if they did not tighten border control to prevent illegal immigration and drug flow into the US. Imposing a 10% blanket tariff would raise \$2 trillion in revenue for the US government from 2025 to 2034. Tariff payments are now collected by the U.S. Customs and Border Protection. Often not mentioned is the benefit to society of tariffs on domestic manufacturing that has a value far beyond what market prices reflect. Yes, moving a factory to China or Mexico can lower the price of a widget, but it raises the price to society.... Manufacturing matters in a country's growth and innovation. Ancillary businesses form and provide jobs. Research and engineering know-how follow manufacturing. Silicon Valley high-tech companies grow and feed off each other. California does not allow non-compete agreements. Employees are free to move from one company to another - analogous to bees fertilizing flowers by moving from one to another.....In the late 1800s and early 20th century, the United States had some of the world's highest tariffs as it

developed its industrial base to become the world's economic power. After World War II, European and Asian countries developed their economies using tariffs and economic policies. The U.S. saw its economic base collapse when it left its domestic manufacturing unprotected with low tariffs, participated in the 1994 North American Free Trade Agreement, and promoted China's entry into the World Trade Organization. China stole billions of dollars of American intellectual property, manipulated its currency, and erected trade barriers to prevent American companies from selling in China.

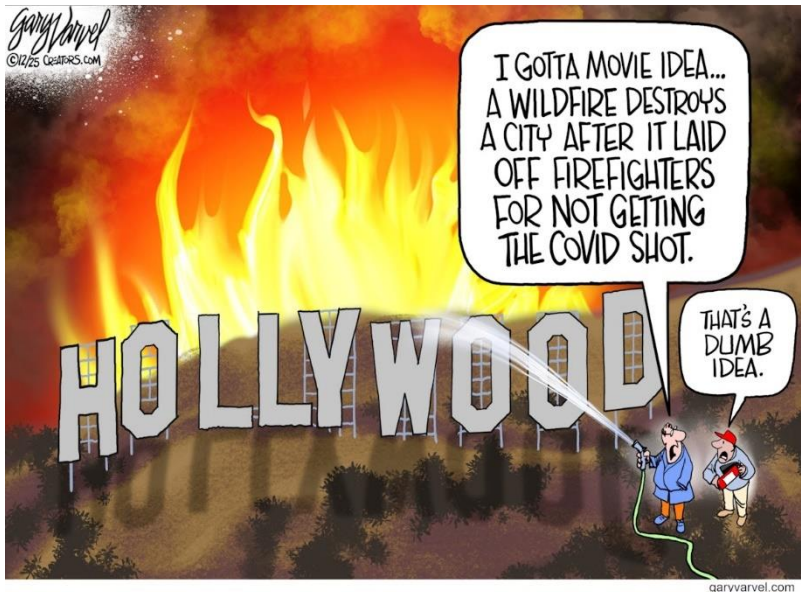
“No more lighters, people,” Newsom said. “From here on out, no one in California will be allowed to do anything as dangerous to public safety as making fire. Problem solved.”

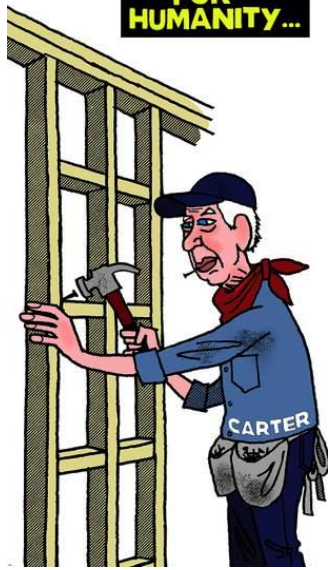

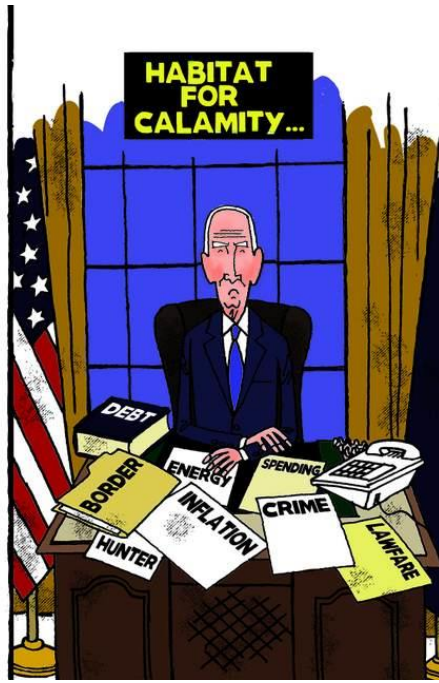
